On that date, firm of Grant Thornton LLP ("**GT**") was appointed proposal trustee ("Proposal Trustee") in the NOI proceedings.

TAKE NOTICE THAT, pursuant to Order of the Court dated July 8, 2020:

The law firm of Cavalluzzo LLP ("**Cavalluzzo**") was appointed as Representative Counsel of all individuals who were contracted by Foodora Inc. to provide courier services and who were actively providing services as of February 3, 2020, and who are represented by the Canadian Union of Postal Workers. Cavalluzzo has reached an agreement in principle with Foodora Inc. and its parent company Delivery Hero SE to settle your claim on favourable terms.

The settlement, should it be finalized, is not a payment on account of termination pay and vacation pay under provincial employment standards legislation that is applicable to

employees, but it will result in you receiving an amount of money that approximates what an employee, with your length of service, would be entitled to for termination pay and vacation pay under that legislation for the period immediately prior to Foodora's commencement of the bankruptcy process.

IF YOU DO NOT WISH TO BE REPRESENTED in the proceeding by Cavalluzzo as Representative Counsel and wish to represent yourself or be represented by another lawyer at your own cost, you must, before July 29, 2020, provide notice in writing (by letter or email) to both Cavalluzzo and GT indicating that you wish to opt-out of such representation:
